PROPOSAL: Retrospective planning application for:- Erection of 3no cement silos, 2no. round metal cylinders, 5m high retaining wall, storage bays. Installation of 12no high lamp posts, diesel tank with metal hoarding surround. Erection of portacabin to be used as temporary site office, temporary storage tent. Construction of settling pit & wash pit.

I am writing to advise that the Planning Inspectorate have amended the Appeal Procedure in relation to the above mentioned appeal. The appeal follows the decision by this Council to refuse planning permission for the above development.

The appeal is to be heard at an Informal Hearing before an Inspector appointed by the Secretary of State. Any comments already made by you at the time of the application for planning permission have been forwarded to the Inspectorate and the appellant, and will be taken into account by the Inspector dealing with the appeal.
